This is with reference to the proposal submitted by Amrita Sai Institute of Science & Technology, Amrita Sai Nagar, Patirala (PO), Kanchikacherla (Mdl), Krishna Dist. Andhra Pradesh-521 180 affiliated to Jawaharlal Nehru Technological University, Kakinada under the UGC Scheme for Autonomous Colleges.

On the basis of the report of the UGC Expert Committee and on the basis of the recommendations of the Standing Committee, the Commission at its meeting held on 09.07.2018 has decided to grant autonomous status to Amrita Sai Institute of Science & Technology, Amrita Sai Nagar, Patirala (PO), Kanchikacherla (Mdl), Krishna Dist. Andhra Pradesh-521 180 affiliated to Jawaharlal Nehru Technological University, Kakinada for a period of ten years w.e.f. 2018-2019 to 2027-2028.

Jawaharlal Nehru Technological University, Kakinada, Andhra Pradesh is requested to issue necessary notification/order regarding the grant of autonomous status to the college as per UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2018 for Autonomous Colleges. The college, if eligible, shall apply for autonomy grant as per the norms laid down in the Regulations.

The autonomous college is required to abide by all the provisions of the UGC Regulations for Autonomous Colleges. The Regulations are available on the UGC website, www.ugc.ac.in. The college shall also apply in the prescribed format to University Grants Commission for extension of autonomous status six months prior to the expiry of the autonomous cycle.


